



The 4th Jumping Frames International Dance Video Competition Entry Rules

- The entrant must be the sole copyright holder of the submitted video work, or must provide proof of rights to submit the work on behalf of the copyright holder.
- The entrant authorises the organiser to use the images and video clippings (less than 20% of total running length) of the submitted video work for promotional purpose, including but not limited to publicity materials, website and publications related to the competition.
- The entrant authorises the organiser the discretion and right to screen the submitted and selected works within a 24-month period from result announcement date.
- The entrant authorises the organiser the right to distribute his/her selected works to dance video festivals or other related events. The entrant will be notified in the situation of entrant's work being screened, selected or awarded by such festivals or events.
- By submitting his/her entries, the entrant agrees to abide by the regulations of the competition.
- The organiser reserves the right to disqualify any entry that contains incomplete or faulty information provided by the entrant.
- The organiser reserves the right of revising or changing the stated regulations and has the final decision on all issues not covered in the entry form.
